

OCEAN DISTANCE SWIM

5K Swim [9:00am] or **1Mile Swim** [9:30am] Sunday, August 21, 2011

Eligibility: Minimum age to participate is 13 as of August 21, 2011.

Entry Fee: Entries for 5K/1Mile postmarked by August 13, 2011: \$40

Late or Race-Day entries: \$50

T-shirts are guaranteed to swimmers who register no later than one week before each event.

<u>Race Charity:</u> The **Virginia Beach Lifeguard Association** is a 501-C-3 non profit organization whose mission is to educate the local community and visitors about ocean safety and to support current surf lifeguards through training, competition and education.

<u>Age Groups/Awards</u>: Awards will be presented to the 1st – 3rd place men and women in each age group. Age groups are as follows (13-15, 16-19, 20-24, 25-29, 30-34 and so on in 5 year increments).

The 5K Course will start at 17th St. on the beach and proceed out 30 meters requiring a left shoulder turn around the initial buoy. Swimmers will then proceed north. There will be a mandatory water stop at 37th St. marked by buoys. The finish will be at 57th St. marked by buoys and on shore flags. Swimmers must complete a left shoulder turn around the final buoy and then make their way into the shore. The finish line will be on the beach. Participants must reach the water stop within one hour of the start of the race or they will not be allowed to continue. Check-in begins at 7:30A.M. and ends at 8:30A.M.

<u>The 1Mile Course</u> will start at 42nd. St. on the beach and proceed out 30 meters requiring a left shoulder turn around the initial buoy. Swimmers will then proceed north. The finish will be at 57th St. Swimmers must complete a left shoulder turn around the final buoy and then make their way into the shore. The finish line will be on the beach.

Depending on the water and tide conditions the start and finish could be reversed.

<u>Packet Pick-up:</u> Packet Pick-up for both races will be available at Aquawear from 12pm to 5pm at Aquawear on Saturday, August 20 and from 7:30am – 8:30am at 17th Street.

<u>Directions To Start:</u> From I-64 take Route I-264 East. When the expressway ends, you are on 21st Street. Take 21st Street to Atlantic Avenue. Turn right on Atlantic Avenue and follow to 17th Street.

<u>Directions to Finish:</u> Same as above but at Pacific Avenue take a left and follow the road to 57th St. Parking is available next to the Wyndham Hotel and across the street.

<u>Start Line Parking:</u> Parking will be available for FREE at the parking lot located just south of the Breakers Resort Hotel at 1503 Atlantic Avenue. (If you need a hotel room, please consider our sponsor; the Breakers Resort (757) 428-1821)
