3K Swim: Sunday, June 30, 2013, 9:30a.m.

5K Swim: Sunday, July 28, 2013, 9:30a.m.

Entry Info: Entries for 3K or 1Mi Option Postmarked by June 24, 2013: \$30.
Entries for 5K or 1Mi Option Postmarked by July 22, 2013: \$30.
Entries for Both Races Postmarked by June 24, 2013: \$55.
Day of Race Entries: \$40.

(Swimmers have option to swim 1 mi in place of 3k & 5k)

Check-in: 17th St. 8:00am. Ends 9:00am. 1-Mi Option Swimmers meet at assigned Street Start by 9:00am.

Eligibility: Minimum age to participate is 13 as of June 15, 2013.

Each entrant Registered by Postmark Date is guaranteed a T-shirt.(Swimmers who compete in both races receive 1shirt.)

Race Charity: The **Virginia Beach Lifeguard Association** is a 501-C-3 non profit organization whose mission is to educate the local community and visitors about ocean safety and to support current surf lifeguards through training, competition and education.

June 30: The 3K Course will start at 17th St. on the beach and proceed out 30 meters requiring a left shoulder turn around initial buoy. Swimmers will then proceed north. There will be a mandatory water stop at 28th St. marked by buoys. The finish will be at 40th St. marked by buoys & on shore flags. Swimmers must complete a left shoulder turn around the final buoy and then make their way into the shore. The official finish line will be on the beach. **Participants must reach the water stop within 40 minutes of the start of the race or they will not be allowed to continue.**

The 1Mi Course will start at 25th St on the beach & proceed out 30 meters requiring a left shoulder turn around the initial buoy. Swimmers will then proceed north. Swimmers must complete a left shoulder turn around the final buoy & then make their way into shore. The official finish will be at 40th St on the beach.

July 28: The 5K Course will start at 17th St. on the beach and proceed out 30 meters requiring a left shoulder turn around initial buoy. Swimmers will then proceed north. There will be a mandatory water stop at 37th St. marked by buoys. The finish will be at 57th St. marked by buoys & on shore flags. Swimmers must complete a left shoulder turn around the final buoy and then make their way into the shore. The official finish line will be on the beach. **Participants must reach the water stop within one hour of the start of the race or they will not be allowed to continue.**

The 1Mi Course will start at 42nd St. on the beach and proceed out 30 meters requiring a left shoulder turn around the initial buoy. Swimmers will then proceed north. Swimmers must complete a left shoulder turn around the final buoy & then make their way into the shore. The official finish line will be on the beach at 57th St.

Depending on water and tide conditions the start and finish could be reversed.

Packet Pick-Up: Packet Pick-Up will be available at Aquawear 12pm - 5pm on Saturday(day before race) & race day 8am – 9am.

Directions: From I-64 take Rte I-264 East. When the expressway ends, you are on 21st Street. Take 21st Street to Atlantic Avenue. Turn right on Atlantic Avenue and follow to 17th Street.

Parking: Parking will be available for FREE at the parking lot located just south of the Breakers Resort Hotel at 1503 Atlantic Avenue. Swim caps will be provided to all entrants / Caps must be worn by all who participate / Water Temp avg. 75 - 80 degrees. / Trucks will be available at the start line to transport swimmers' bags to the finish line / All swimmers must check-in race day on the beach at 17th St / Restrooms are available at 17th St Park / THERE WILL BE NO REFUNDS. WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

1. I hereby represent that (i) I am in good health and in proper physical condition to participate in the Event; and (ii) I am not under the influence of alcohol or any illicit or prescription drugs which would in any way impair my ability to safely participate in the Event. I agree that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in the Event.
2. I understand and acknowledge the physical and mental rigors associated with triathlon, duathlon, or other multi-sport events, and realize that running, bicycling, swimming and other portions of such Events are inherently dangerous and represent an extreme test of a person's physical and mental limits. I understand that participation involves risks and dangers which include, without limitation, the potential for serious bodily injury, permanent disability, paralysis and death; loss or damage to property; exposure to extreme conditions and circumstances; accidents, illness, contact or collision with other participants, spectators, vehicles or other natural or manmade objects; dangers arising from adverse weather conditions; imperfect course conditions; water, road and surface hazards; equipment failure; inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the Event Organizers; and other undefined harm or damage which may not be readily foreseeable, and other presently unknown risks and dangers ("Risks"). I understand that these Risks may be caused in whole or in part by my own actions or inactions, the actions or inactions of others participating in the Event, or the acts, inaction or negligence of the Released Parties defined below, and I hereby expressly assume all such Risks and responsibility for any damages, liabilities, losses or expenses which I incur as a result of my participation in the Event.
3. I agree to be familiar with and abide by the Rules and Regulations established for the Event, including but not limited to the Guide to Prohibited Substances and Prohibited Methods of Doping adopted by the United States Anti-Doping Agency. I also accept sole responsibility for my own conduct and actions while participating in the Event, and the condition and adequacy of my equipment.

I hereby Release, Waive and Covenant Not to Sue, and further agree to Indemnify, Defend and Hold Harmless the following parties: the Event Organizers and Promoters, Race Directors, Sponsors, Advertisers, Host Cities, Local Organizing Committees, Venues and Property Owners upon which the Event takes place, Law Enforcement Agencies and other Public Entities providing support for the Event, and each of their respective parent, subsidiary and affiliated companies, officers, directors, partners, shareholders, members, agents, employees and volunteers **Individually and Collectively, the "Released Parties" or "Event Organizers"**, with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss or expense (including court costs and reasonable attorneys fees) of any kind or nature ("**Liability**") which may arise out of, result from, or relate to my participation in the Event, including claims for Liability caused in whole or in part by the negligence of the Released Parties. I further agree that if, despite this Agreement, I, or anyone on my behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liability which any may be incurred as the result of such claim.
