The Masters program is worldwide and growing. The FINA Handbook lists 146 countries involved with Masters swimming. Our Masters Program will become even stronger as we increase our membership, bringing new members with innovative ideas to the program. So let's move ahead in Virginia with a strong Masters Swim Program.

Report from the Registrar...

The newsletters are sent by bulk mail. The Post Office does not forward bulk mail. If you move, please send me your new address. If you are receiving the newsletters late, let me or Beth Waters (VMST president) know. With bulk mail it is hard to tell if newsletters are getting across the state in a timely manner.

At this time, we have 353 swimmers in Virginia and four teams. The teams are: Virginia Masters Swim Team (VMST), Northern Virginia Masters Swimming (NVMS), Roanoke Masters Aquatic Club (RMAC), and Valley Blues Swim Club (VBSC). Approximately forty swimmers are registered as Unattached.

The entries for our two open water swims are enclosed in this newsletter. Entries will also be mailed to last year's participants who are not LMSC members. Please remind swimmers on your team or in your workouts that they need to have their USMS registration card before sending in their entry to these events. The Jack King Ocean Swim is June 19; the lake swim in Charlottesville (at Chris Greene Lake) in July 9.

Raymond Snead, a long time participant in Masters Swimming, died December 21; he was 64. Raymond was always proud of the fact that he was not a good swimmer when he began Masters Swimming, but through swim camps and hard work, he became a state record holder in freestyle and butterfly. Raymond did not compete the last few years, but was very active for 10 or 12 years.

10K-2 10,000 METER 2 PERSON POSTAL MEET RELAY

Sponsored by: Virginia Masters Swim Team

Eligibility: Open to all swimmers ages 13 and older.

Event: Contestants swim a total of 10,000 meters in the pool of their choice. Team members must swim consecutive lengths of no less than 50 yards per relay leg. Concurrent swimming is not permitted. One swimmer must reach the wall before the second swimmer leaves. Dive starts are permitted.

For example, swimmers may wish to divide the 10,000 meters as follows: Swimmers A and B alternate 200 meter swims until each has completed 15 separate 200 meters wims (of 3,000 meters apiece). Then swimmers A and B alternate 15-100 meters swims each for another 1500 meters: and close with 10-50 meter swims each.

· In a 20 yard pool, *each contestant swims 274 lengths

- In a 25 yard pool, "each contestant swims' 219 lengths
- · In a 25 meter pool, each contestant swims 200 lengths
- In a 50 meter pool, each contestant swims 100 lengths

For the purposes of this competition, 5480, 5475** yards = 5000 meters.

Age Groups: Men's, women's, mixed teams in the following age groups: 13-19. 20-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, 70-74, 75-79, 80-84, 85-89, 90+.

Team age determined by youngest swimmer's age on the day of swim.

Timers and Counters: Please pay strict attention to the laps swum. We urge you to use a check-off system.

Awards: Medal keychains to the top three team finishers (men's, women's, mixed) in each age group.

Entry: Enter as often as you like (\$16 entry fee required for each new team.)

Entry fee: \$18 per team. Event must be swum between May 15 and October 15, 1994. Form must be in the hands of Meet Director by October 31, 1994.

NATIONAL MASTERS 2-NAILLE Cable Swim - Quarter-mile Straightaway

CHRIS GREENE LAKE -CHARLOTTESVILLE, VIRGINIA SATURDAY, JULY 9, 1994

EVENT: The first heat will be swum counter clockwise and will start at 9 a.m. Check-in for the first heat will close promptly at 8:45. The second heat will be required to check in by 10:45 for an anticipated start immediately upon completion of the first heat. The second heat will be swum clockwise.

For safety reasons, swimmers who cannot complete the 2 miles in 2 hrs. are advised not to enter. Swimmers still on course after 2 hrs. will be stopped. From the standpoint of results, these swimmers will be indicated as not having completed the swim.

INDIVIDUAL AGE GROUPS: 19-24, 25-29, 30-34, and so on, in five year increments as high as necessary for both men and women.

TEAMS: Men's, women's and mixed sex teams will be permitted. Age groups will be 19+, 25+, 35+, and so on, in ten year increments as high as necessary. The age of the youngest team member shall determine the age group.

TEAM EVENT: A team shall consist of 3 swimmers. All team members must be registered as individual entrants and registered with the same Masters - affiliated club; i.e. Virginia Masters, Triad Masters, etc. Team Entries must be submitted on a 3 x 5 card providing the

information as shown on the "sample" card on the back of this form.

AWARDS: Medals will be awarded to the top 3 individual finishers and to the 1st, 2nd and 3rd place teams in each age group. National Masters Championship patches to all individual first place finishers.

ENTRY FEES: Payable to Virginia Masters. Individual: \$10 per individual. Team: \$15 per team. Team members must also register as individual entrants. Late and deck entries will not be accepted. "No Time" entries will be seeded last in appropriate heat.

REGISTRATION: All swimmers must be registered with their Local Masters Swim Committee (LMSC). Entrants must include a photo copy of their 1994 USMS registration card with their entry form. Entries received without a copy of their 1994 card will be returned. Please do not show up at Chris Greene Lake planning to register or enter. Advance entry and registration are required to swim.

ENTRIES: Official form, entry fees, and 3x5 card for team entries must be received no later than July 1, 1994. If you wish to purchase a commemorative T-shirt, your entry and prepaid shirt order must be received no later

ENTRANCE TO LAKE: Swimmers and meet workers will be admitted free. For all others, Chris Greene Lake requires the following entrance fees prior to mittance: Albemarle County residents: adults, \$2; children (4-12), \$1. Nonresidents: adults, \$3; children (4-12), \$2.

SOCIAL: Fresh fruit and snacks, along with beer and soft drinks, will be provided immediately following the meet. Tickets at \$3 per individual must be purchased at the time the entry form is submitted.

T-SHIRTS: National Masters 2-Mile T-shirts will be available only on a pre-order and pre-payment basis. T-shirts are 2 color, 100% cotton.
